#### <u>Capital Improvement Plan</u> (CIP)

Multi-Year Plan of proposed capital projects and forecasts future spending needs

#### **Capital Budget**

First year costs of the Capital Improvement Plan – these are the projects and expenditures requiring a vote by the Board

# **Capital Project Definitions**

- Acquisition or construction of a facility
- Acquisition of land or an interest in land
- Ongoing acquisition of assets such as major equipment or physical systems (i.e., computer technology, radio systems, vehicles, etc.)
- Modification to facilities, including additions to existing facilities that increase the square footage, useful life, or value of the facility
- Capital maintenance or replacement projects on existing facilities

## **Changes from Prior CIPs**

- Budget Capital Projects out of multi-year project funds rather than General Fund
  - General fund revenue will be transferred to multi-year funds
- Does not include funding for regular repairs & maintenance for ABSS, ACC, and AC, sometimes referred to as PAYGO projects or capital outlay
  - These are included in the Recommended Operating Budget you will receive on May 19th
- CIP includes funding for vehicles and equipment previously budgeted in the Operating Budget

# **Proactive Budgeting**



- Discussed the need for proactive budgeting and data-driven decisionmaking at the Board Retreat as our resources shrink and the needs of our aging infrastructure grow
- Planning for necessary roof replacements, HVAC replacements, and technology replacements rather than waiting until they reach the stage of causing safety and security issues

# Highlighting Projects and Expenditures



## **FY25-26 Capital Expenditure Drivers**



#### ABSS FY25-26 Capital Budget: \$11.4 million

- Roof Replacements: \$5.1 million
- HVAC Replacements: \$4.8 million
- Technology Equipment: \$1.4 million

# Phase II Joint Study – Structural Needs



- Phase I (FY24-25) Issued Bonds for \$19 million
  - ABSS Facility Roof and HVAC Replacements

• Phase II (Years 2-10) – General Fund Transfer: \$10 million/year beginning FY25-26

## **FY25-26 Capital Expenditure Drivers**



#### ACC FY25-26 Capital Budget: \$0

- ACC will continue to work on completing previously funded bond projects including the Public Safety Training Center construction
- ACC requests no additional funding for capital improvement projects in FY25-26 while the college completes a Facilities Condition Assessment

• ACC anticipates submitting a 5-Year capital improvement plan in FY26-27 based on the assessment

# **FY25-26 Capital Expenditure Drivers**

#### AC FY25-26 Capital Budget: \$19.0 million

- Facilities Improvements\*: \$13.6 million
  - Landfill Projects: \$11.6 million (enterprise fund)
- Technology: \$878 thousand
- Equipment and Vehicles\*: \$4.5 million
  - Landfill Projects: \$2.0 million (enterprise fund)

# **Potential Future Impacts**

- Recommended projects for FY25-26 are sustainable without impacting the property tax rate
- Mebane EMS Base will require additional EMTs/Paramedics in FY26-27 along with operating costs but will not need additional ambulances
  - Estimated annual operating impact: \$1.5 million
